5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at date mentioned above at Balra Municipality Office, Balra, Sarlahi. Non-attendance of any or all of the Bidders' representatives shall not hinder the opening of the bids. Bids must be valid for a period of as mentioned in table below after the date of bid opening.

Bids must be valid for a period of days mentioned above after bid opening and must be accompanied by a Bid Security or Scanned copy of Bid Security in .pdf format of minimum amount specified in table above. The Bid Security shall be valid for 30 days beyond the bid validity period. Bidder must clearly quote the contract name and contract number in Bid security form (Bank guarantee) otherwise will cause disqualification of Bidder.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
